THIS INSURANCE AGREEMENT to provide an INFLATABLE OR OTHER ENTERTAINMENT at the Event described below (this "Agreement"), entered into this _____ day of _____, 20____, by and between NORTH CODORUS TOWNSHIP, a Second Class Township organized and existing under the laws of Pennsylvania (the "Township") and _____, ("Renter").

IN CONSIDERATION of receiving permission to provide entertainment, such as, but not limited to, a bounce house, other similar inflatable or live entertainment (collectively, the "Inflatables"), Township's community park property during the _____ Event (hereinafter, the "Event") and which is to take place on _____, 2025, the Renter hereby agrees as follows:

1. In General. The term of this Agreement shall coincide with the Event.
2. Release. The Renter hereby releases and forever discharges the Township, its agents, officers and employees from any and all claims and demands for personal injury and property damage, including attorney's fees, arising out of or in connection with the placement, installation, use and operation of the Inflatables.
3. Indemnity. The Renter shall indemnify, defend and hold harmless the Township, its agents, officers and employees from and against any and all claims and demands of any kind or nature, directly or indirectly caused by, arising out of, or related to the intentional or negligent acts or omissions of the Renter its guests, licensees, invitees, agents, officers, employees or sub-contractors in connection with the placement, installation, use and operation of the Inflatables.
4. Insurance. During the Event, the Renter shall maintain the following insurance policies and comply with the following requirements:
 - (1) General Liability Insurance, including but not limited to coverage for all premises and non-premises operations, independent contractors, personal injury liability protection, employment of persons, contractual liability protection, and products and completed operations coverage. This insurance shall provide bodily injury and property damage limits of not less than \$1,000,000 for each occurrence.
 - (2) The Renter will provide a Certificate of Insurance, evidencing such insurance. The Township of shall be named as an additional insured in the General Liability policy and it shall be stated on the Insurance Certificate with the provision that this coverage is primary to any other coverage the Township may possess. Should the Renter fail to provide acceptable evidence of current insurance at least seven days prior to the Event, the Township may in its sole discretion cancel the reservation or prohibit the Inflatables at the Event.
